On Wednesday September 1, 2021 the Ontario Provincial Government issued a statement that, a Proof of Vaccination Policy has been issued. The TAAA rents the ice facilities at the Thorold Community Arenas. All persons entering the arena facilities will be required to follow the Vaccination Policy Guidelines of The City of Thorold. Currently, the City of Thorold is reviewing their policy and are awaiting a formal regulation. We are anticipating that Proof of Vaccination will be required to enter the facilities **effective as of September 17, 2021**. Further and final details will be communicated in the near future. Each facility will have a different Policy based on their Municipal Regulations and Guidelines. When visiting other facilities, please be informed of their policies.

On Friday, September 3, 2021 the OMHA (Ontario Minor Hockey Association) had also released their official Vaccine Policy. The TAAA is governed by the OMHA. The OMHA provides rules, regulations, and insurance for the TAAA and all other association's we participate with.

The TAAA is required to follow all policies set forth by the OMHA. At this time, to participate in our association's sanctioned events, Proof of Dual Vaccination will be required. This policy effects all participants, volunteers, parents etc. born prior to 2009. . You will be required to have your 2<sup>nd</sup> dose of the vaccination by October 17<sup>th</sup> to ensure you meet the OMHA deadline of October 31, 2021 for proof of vaccination. TAAA will gather records at that time to satisfy the OHMA Policy. Please view the following links for more detailed information.

- If you request a full refund (that has been refunded) due to the Vaccination Policy and wish to re-register with the TAAA Hockey due to a future policy change . Registration will be subject to an administration fee of \$100.00.
- Re registration will be subject to Space Availability
- If you request a refund after you have participated prior to October 31, 2021 you will be subject to a \$50.00 administration fee with a proration fee for ice time.
